Challenges to democracy, the rule of law, and pluralism

- Extraordinary situations are frequently dealt with by concentrating the state power in the hands of one or a few institutions or branch(es) of the state power, which creates challenges with respect to separation of powers – what safeguards are there / should be there to guard against possible abuse?
- Essential processes of a functioning democracy may become impossible or impracticable during times of emergencies, but how to ensure that the adjustment of those processes does not perpetuate beyond the time when and to the extent to which it is strictly necessary?



- A proper legislative procedure requires consultations with all affected parties. However, does the weight to be afforded to the opinions and concerns of various minorities decrease when the life of the nation is under threat?

- Extraordinary situations frequently necessitate more stringent restrictions on fundamental rights, but where are the “red lines” that may not be crossed even in such circumstances?
