Environmental sustainability: a political choice or a matter of fundamental rights?

- *in recent years, several national courts (e.g. the courts of France, the Netherlands and Germany) have assessed whether the measures taken by states have been sufficient to prevent climate change and whether a person has the fundamental right to require a state to take the necessary measures to ensure environmental sustainability; similar issues are relevant in a number of cases that have already been examined or will soon be heard before the European Court of Human Rights. These rulings raise questions about the role of the courts in ensuring environmental sustainability, and the limits of the courts' jurisdiction*
- *a related topic is the normativisation of the right to a benevolent environment*
